COVID-19 SAFETY AUDITS

HazTek's Biohazard Safety Supervisors will audit your project's compliance with federal, state, local, site-specific, and corporate protocols to reduce the risk of occupational illness due to the novel coronavirus.

RESPIRATORY PROTECTION

RESPIRATORY PROTECTION PROGRAMS

HazTek can develop or refresh your Corporate Respiratory Protection Program to meet today's requirements.

RESPIRATORY PROTECTION TRAINING

The novel coronavirus has expanded the population of respirator wearers on most jobsites and OSHA requires all employers to train respirator wearers in their proper use, cleaning, and storing.

RESPIRATOR FIT TESTING

HazTek can perform qualitative and quantitative fit testing for all employees wearing tight-fitting facepiece respirators, such as N95, half-, and full-face respirators. Fit Testing is NEITHER required nor effective for face coverings designed for source control or as a physical barrier, such as surgical masks and cloth face coverings used in place of PPE.

MEDICAL CLEARANCE

Through HazTek's network of trained medical technicians, we can ensure employees are medically cleared to wear a respirator prior to doing so. Respirator clearances are performed under the direction of a licensed Occupational Health Professional and are required prior to both voluntary and mandated use of respiratory protection.

HazTek has developed LIVE training programs delivered by qualified instructors through virtual platforms for nearly all of the 75+ courses we offer. VIRTUAL PRACTICAL HYBRID (VPH) TRAINING PROGRAMS

HazTek's VPH training programs are specially designed for programs that require some hands-on component, such as programs combining classroom instruction with a practical operator evaluation. We've developed a creative delivery model for applicable courses that adheres to social distancing and disinfecting protocols while increasing the productivity of your workforce. Each course is different and each client is unique, so please call us to learn more about our exclusive approach to training your workforce.

OSHA 10- AND 30-HOUR CONSTRUCTION OUTREACH

HazTek can currently deliver both of these courses immediately in both English and Spanish because most regional OSHA Training Institutes (OTI) have lifted the standard 60-day waiting period for delivering these classes remotely. Training is done in modules and class sizes are limited to help employees stay focused, monitor participant attendance, and encourage seamless interaction with our instructor.

Delivered as a VPH program, HazTek can train your workforce pursuant to NCCCO or CIA requirements in a matter of days. Our instructors are subject matter experts in their fields and we've successfully delivered numerous programs via our innovative VPH delivery model.

WRITTEN PROGRAMS

PANDEMIC PREPAREDNESS PLAN

HazTek's Pandemic Preparedness Plans are intended as a standalone section to be added to your Corporate Health and Safety Plan. Our Pandemic Preparedness Plans are developed to address any pandemic threat and satisfy the requirements of most 3rd Party Verification services such as ISNetworld, BROWZ, Avetta, and ConstructSecure.

CORPORATE COVID-19 PREPAREDNESS AND RESPONSE PLAN

Pursuant to your Pandemic Preparedness Plan, our Corporate COVID-19 Preparedness and Response Plans are customized and specific to the current pandemic and establish companywide minimum requirements for your projects, yards, shops, and office facilities. A HazTek Senior Consultant will work directly with your team to develop policies and procedures that meet your unique expectations.

COVID-19 REOPENING AND REMOBILIZATION PLAN

This plan is similar to our Corporate COVID-19 Preparedness and Response Plan; however, it provides additional protocols for restarting a project that was previously shut down due to a confirmed or suspected case of COVID-19. A HazTek Senior Consultant will work directly with your team to develop policies and procedures that meet your unique expectations.

WRITTEN PROGRAMS, CONT.

SITE-SPECIFIC COVID-19 HEALTH AND SAFETY PLAN (COVID-19 SHASP)

HazTek's COVID-19 SHASP is more granular than the COVID-19 PRP and COVID-19 RRP in that it addresses state, local, and project owner requirements. A HazTek Senior Consultant will work directly with your project team to develop a detailed plan that may include the location of hand washing stations and restroom facilities, use of source control and PPE, logistics plans, and site entry and exit protocols.

COVID-19 JOB SAFETY ANALYSIS (JOB/TASK/ACTIVITY HAZARD ANALYSIS)

HazTek can prepare a COVID-19 Job Safety Analysis that defines the safe work practices associated with your workers' specific tasks. For example, special protocols may be necessary for work requiring two or more workers that cannot maintain a social distance of six feet. This is our most granular, task-specific document that's often used as the basis for a Toolbox Talk or daily safety briefing.

COVID-19 CASE MANAGEMENT AND RETURN TO WORK PROCEDURES

HazTek's COVID-19 Case Management and Return to Work Procedures address your requirements for bringing an employee back to work who may have tested positive, been diagnosed, or was suspected of having COVID-19. These procedures are included in HazTek's COVID-19 PRP and RRP; however, it can be added as an attachment if your initial plan was developed by someone other than HazTek.

COVID-19 TRAINING

HAZTEK BCR (BIOHAZARD CONTROL AND RESPONSE) TRAINING FOR SUPERVISORS

This 4-hour course is designed to prepare safety and operations personnel for implementing a Biohazard Control and Response Program for projects and facilities impacted by COVID-19. The course will provide the knowledge required to serve as a COVID-19 Supervisor, COVID-19 Safety Officer, Pandemic Safety Officer, or other person in charge of administering the necessary controls to assure that site workers are protected from exposure to the coronavirus and to maintain a productive work environment in a challenging situation.

HAZTEK BCR AWARENESS TRAINING FOR WORKERS

This 2-hour awareness level course is intended for site workers at projects and facilities impacted by COVID-19. The course will provide workers with the knowledge to identify unsafe work practices and conditions and perform their jobs safely while maintaining a productive work environment in a challenging situation.

COVID-19 LUNCH AND LEARN

COVID-19 Lunch and Learns are free for HazTek customers and others working on their projects. Lunch and Learns offer a compilation of recommended best practices from various government organizations (OSHA, CDC, NIH) and address federal, state, and local requirements. Project-specific requirements can be built into the LNL. LNL's typically include about 40 minutes of presentation followed by 10-15 minutes of Q&A.
